## USMLE/COMLEX Scores, Medical Licensure, & Board Certification

All eligible applicants will be considered for GME. The Board process will take all unique circumstances into consideration.

<u>Licensing Exams:</u> ALL APPLICANTS are required to upload into MODS a copy of the <u>official transcript</u> from the NBME or NBOME showing <u>all</u> attempted exams (with dates) and scores. <u>INDIVIDUAL SCORE REPORTS ARE NOT ACCEPTABLE.</u>

**MEDICAL STUDENTS:** Selection for Graduate Medical Education (GME) is a competitive process that occurs through the Joint Graduate Medical Education Selection Board (JGMESB).

- 1) You must attempt the Step/Level 2 licensing exams prior to the board.
- 2) You must upload into MODS the complete NBME or NBOME transcript with Step/Level 1 and 2 scores no later than **15 October**, showing all exam dates and scores including unsuccessful attempts. Keep in mind that it may take up to 6 weeks to receive your results after you test.
- 3) Students may have a medical school official complete a score report letter with documentation of all test attempts. A template is provided in the Other Resources section of the <a href="Physician Education website">Physician Education website</a>.

**NOTE:** Selection for GME is contingent upon successful completion of Steps/Levels 1 and 2 and graduation from medical school prior to the start of GME (1 July). If you are unable to successfully complete these requirements by 1 July, your case will be evaluated for action by Physician Education (i.e., academic leave of absence, separation with recoupment of scholarship, etc.).

<u>CURRENT INTERNS:</u> You must have <u>scheduled</u> Step/Level 3 no later than **15 October**. The test date must be submitted with your application on the "Step/Level 3 Intention Form" available in the Other Resources section of the <u>Physician Education website</u>.

Step/Level 3 must be <u>taken</u> prior to **30 March**, with passing results received by Physician Education no later than **30 April (or score release date)**. Selection for GME is contingent on successful completion of the Step/Level 3 licensing exam. There are no exceptions to this requirement.

<u>CURRENT RESIDENTS & STAFF PHYSICIANS:</u> You are required to upload into MODS a copy of the official transcript from the NBME or NBOME showing all current exam dates and scores, including Step/Level 3. *INDIVIDUAL SCORE REPORTS ARE NOT ACCEPTABLE*.

<u>Licensure</u>: All applicants who have successfully completed a PGY1 must provide a copy of their current, unrestricted state medical license in accordance with AFI 44-119, paragraph 4.4.1. The license must be a current, unrestricted, state issued medical license with license number and expiration date. Internet verifications or a copy of a wallet card are preferred. A training license is NOT an unrestricted license.

The <u>Federation of State Medical Boards website</u> has additional information regarding licensing requirements in each state.

**<u>Board Certification:</u>** Board certification is required for all applicants who have completed a full residency. If Board Certification is pending, this must be addressed in the Personal Essay.
