AUTHORITY: Title 10, U.S.C. Chapter 55, Sections 1094 and 1102.

PRINCIPAL PURPOSE: To define the scope and limits of practice for individual providers. Privileges are based on evaluation of the individual's credentials and performance.

ROUTINE USE: Information on this form may be released to government boards or agencies, or to professional societies or organizations, if needed to license or monitor professional standards of health care providers. It may also be released to civilian medical institutions or organizations where the provider is applying for staff privileges during or after separating from military service.

APPLICANT: In Part I, enter Code 1, 2, or 4 in each REQUESTED block for every privilege listed. This is to reflect your current capability. Sign and date the form and forward to your Clinical Supervisor

CLINICAL SUPERVISOR: In Part I, using the facility master privileges list, enter Code 1, 2, 3, or 4 in each VERIFIED block in answer to each requested privilege. In Part II, check appropriate block either to recommend approval, to recommend approval with modification, or to recommend disapproval. Sign and date the form and forward the form to the Credentials Office.

CODES: 1. Fully competent within defined scope of practice.

2. Supervision required. (Unlicensed/uncertified or lacks current relevant clinical experience.)

3. Not approved due to lack of facility support. (Reference local facility privilege list. Use of this code is reserved for the Credentials Committee/Function.)

4. Not requested/not approved due to lack of expertise or proficiency, or due to physical disability or limitation.

P389192	The scope of privileges for a Pharmacist includes evaluation and interpretation of physician's orders (written and verbal) for appropriateness of drug therapy, and monitoring for drug interactions, overdosage and adverse reactions. Pharmacists review of proper drug selection, subtherapeutic dosages, overdosages, adverse drug reactions, and drug interactions in the inpatient and outpatient settings. Pharmacists document pharmaceutical care activities in the medical record as appropriate. Pharmacists prepare, compound, and dispense pharmaceuticals for patients of all ages in the inpatient and outpatient setting, conduct education for patients and healthcare professionals, and ensure proper handling and dispensing of investigational drugs.		
P389194	The scope of privileges for a Clinical Pharmacist includes the evaluation, management and consultation regarding drug therapy for patients of all ages with selected diagnoses defined by MTF policy. Clinical Pharmacists obtain a health and drug history, perform limited physical assessments to assess drug therapy, evaluate the need for and interpret relevant laboratory tests, prescribe the most appropriate treatment regimen and educate patients regarding their medications. Clinical Pharmacists recognize and ensure appropriate remediation of improper drug selections, subtherapeutic dosages, failure to receive drugs, overdosages, adverse drug reactions, and drug interactions in the inpatient and outpatient settings
